

Flinders Online tuition fee discount for Domestic Alumni and Flinders Staff

Value

Flinders Alumni

- a) A 30% discount in tuition fees for those who have graduated in the last 3 years; or
- b) A 20% discount in tuition fees for those that have graduated 3 or more years ago.

Current Flinders Staff

- A 30% discount in tuition fees is available.
- Flinders staff can also access the staff professional development fund of up to \$4,000 in conjunction with the discount (subject to meeting eligibility criteria).

Eligibility

Applicants must:

- Meet the minimum course entry requirements; and
- Be graduates of a Flinders undergraduate or postgraduate course to be eligible for the Alumni discount; or
- Be current staff, fixed term (for the period they are employed by Flinders) and continuing staff who have been here longer than 6 months, to be eligible for the staff discount; and
- Must be an Australian or New Zealand citizen or an Australian permanent resident or permanent humanitarian visa holder at the time of application.
- Available to applications of an eligible course as outlined in the Terms and Conditions.

Terms & Conditions

- An application for an eligible program will constitute an application for the discount.
- The discount will be applied to the Student Contribution fee for the student's chosen course. This includes both Commonwealth Supported Places (CSP) and Full-Fee Paying Places (FFP), as well as students with credit transfers from Flinders University or other institutions.
 - A Commonwealth Supported Place (CSP) is a course subsidised by the Commonwealth Government for domestic students. CSP students will pay the subsidised fee as their Student Contribution.
 - A Full-Fee Paying Place (FFP) is a course not subsidised by the Commonwealth Government. FFP students will pay the full course fee as their Student Contribution.
- Eligible recipients can defer their discounted tuition fee or student contribution through a HELP loan. The discount cannot be retrospectively applied to admitted students who have commenced the course in previous years.
- There is no financial payout of any unexpended portion of this discount, nor is it refundable if a recipient withdraws from the course or is withdrawn due to unsatisfactory academic progress.
- The discount is not transferrable to a third party.
- The discount will not be extended beyond any advertised duration or amount unless otherwise advised by Flinders University.
- The discount will be revoked if any information submitted with the application is found to be false or misleading.
- The discount may not be available again to recipients who withdraw from the course after commencement and then reapply for readmission in a later year(s).
- Should an applicant be eligible for both the Alumni and Staff discount, the Staff discount (30%) will be applied if successful in their application for entry.
- The discount is not available to students on other Flinders University scholarships.
- Applicants eligible for the Staff discount should note they may be subject to Fringe Benefit Tax if there is not sufficient connection between the employee's current role and their course.
- The discount will be ceased if the staff member ceases employment with Flinders University.
