

Statutory declaration for Rural/Remote and Northern Territory residency Instructions to applicants

This form can be used to apply for:

- Flinders University rural and remote subquota
- Flinders University Northern Territory subquota

You may supply one statutory declaration to cover all subquotas/pathways for which you are eligible.

Instructions

- 1. Print out the statutory declaration and fill in your personal details at the top.
- 2. List the addresses which establish that you meet the requirements of the subquotas/pathways you wish to be considered for – refer to undergraduate course search for more information about eligibility requirements.
 - You must provide full addresses
 - Dates of residence must include the month and year
 - Draw a line through any blank rows
- 3. Sign and date the form by hand before an authorised person see page 3 of the form for a list of authorised witnesses.
 - The witness must sign the form by hand and supply all details requested at the bottom of the form, including their position which allows them to be an authorised witness, for example Registered Nurse, Pharmacist, Full Time Teacher, etc.
 - A stamp which includes the required information is acceptable
- 4. Upload the completed form to the 'Upload Documents' section of your Internal Transfer application, or email it to: askflinders@flinders.edu.au

If you do not provide all required details, your statutory declaration will not be accepted.

Amendments

Any amendments made to the form must be initialled by both the applicant and the same authorised person who witnessed the statutory declaration. Unwitnessed amendments will not be accepted.

Note 2: Chapter 2 to the *Criminal Code* applies to all offences against the Statutory Declarations Act 1959 – see section 5A of the *Statutory Declarations Act 1959*

- employee of a Commonwealth authority engaged on a permanent basis with 5 or more years of continuous service who is not specified in another item in this Part
- o employee of the Australian Trade and Investment Commission who is:
 - a. in a country or place outside Australia, and
 - b. authorised under paragraph 3(d) of the Consular Fees Act 1955, and
 - c. exercising his or her function in that place
- o employee of the Commonwealth who is:
 - a. in a country or place outside Australia, and
 - b. authorised under paragraph 3(c) of the Consular Fees Act 1955, and
 - c. exercising his or her function in that place
- o engineer who is:
 - a. a member of Engineers Australia, other than at the grade of student, or
 - b. a Registered Professional Engineer of Professionals Australia, or
 - c. registered as an engineer under a law of the Commonwealth, a state or territory, or
 - d. registered on the National Engineering Register by Engineers Australia
- finance company officer with 5 or more years of continuous service
- holder of a statutory office not specified in another item in this list
- judge
- Justice of the Peace
- magistrate
- o marriage celebrant registered under Subdivision C of Division 1 of Part IV of the Marriage Act 1961
- master of a court
- o member of the Australian Defence Force who is:
 - a. an officer, or
 - b. a non-commissioned officer within the meaning of the Defence Force Discipline Act 1982 with 5 or more years of continuous service, or
 - c. a warrant officer within the meaning of that Act
- member of the Australasian Institute of Mining and Metallurgy
- o member of the Governance Institute of Australia Ltd
- o member of:
 - a. the parliament of the Commonwealth, or
 - b. the parliament of a state; or
 - c. a territory legislature, or
 - d. a local government authority
- o minister of religion registered under Subdivision A of Division 1 of Part IV of the Marriage Act 1961
- o notary public, including a notary public (however described) exercising functions at a place outside:
 - a. the Commonwealth, and
 - b. the external territories of the Commonwealth
- permanent employee of the Australian Postal Corporation with 5 or more years of continuous service who is employed in an office supplying postal services to the public
- o permanent employee of:
 - a. a state or territory, or a state or territory authority, or
 - b. a local government authority with 5 or more years of continuous service, other than such an employee who is specified in another item of this Part
- o person before whom a statutory declaration may be made under the law of the state or territory in which the declaration is made
