CAREER SUMMARY

I have a sustained record of leadership in research, teaching, community service and administration. My academic life is driven by three passions. The first is to use archaeology, anthropology and heritage studies to convey the sophistication of Indigenous cultures and the unique accomplishments of Indigenous Australians. The second is to contribute to global equity and intellectually enriching archaeology by addressing the barriers faced by scholars in countries with low exchange rates, especially those who do not normally publish in English. The third is to nurture the next generation of scholars who make a difference.

My field research is characterized by deep relationships with specific Aboriginal communities. Since 1990, I have conducted extended annual research with the Barunga community, located in a remote area of the Northern Territory. In South Australia I have worked closely with Ngadjuri people since 1998 and with Adnyamathahna people since 2021.

My leadership within a global context has been enacted most notably as the twice-elected president of the World Archaeological Congress and as Editor of the 20 volume *Encyclopedia of Global Archaeology* (5.6 million accesses in March 2026). I have been the principal or co-principal organizer for three World Archaeological Congresses: WAC-5 in Washington, DC, USA, 2003; WAC-7 at the Dead Sea, Jordan, 2013; and WAC-10 in Darwin, Australia, 2025.

Indigenous knowledge systems and archaeology, rock art, symbolic communication, the evolution of social complexity, contact archaeology, gender, community archaeology/participatory archaeology, archaeological ethics, cultural heritage, archaeology of the contemporary past, conflict archaeology, the museum, globalization, socially mediated terrorism, and global social archaeologies.

United States National Science Foundation Science and Technology Center for Braiding Indigenous Knowledge and Science (2243258)

Led by Sonya Atalay (U. Mass at Amherst). Kellie Pollard and Claire Smith Co-Leads of Australian Hub

The Center for Braiding Indigenous Knowledges and Science (CBIKS) will examine how to effectively and ethically combine Indigenous Knowledges (IK) and conventional “Western” science (WS) through research at the interface of three interconnected research areas of climate science, archaeology, and food systems. Combining IK and WS involves “plural coexistence” of two very different knowledge systems, a process Mi’kmaq peoples call ‘two-eyed seeing’ and which we refer to as ‘braiding knowledges’. We have evidence of Indigenous Knowledge’s scientific potential for better understanding long-term

environmental shifts, biodiversity, and archaeological sites. Geoscientists, archaeologists, and climate scientists demonstrate an interest in knowledge co-production with Indigenous people. Yet Indigenous Knowledges remains at the margins of scientific research. Our vision is that braided IK/WS methodologies become mainstream in scientific research. That they are utilized by scientists in collaboration with Indigenous communities to address complex scientific problems and provide place-based solutions that address the existential threat of climate change and its urgent impacts on cultural places and food systems. We envision a generation of connected and supported students, scientists, and Indigenous communities with the skills and training to conduct and apply research using braided IK/WS methodologies.

ARC Training Centre for Advancing Archaeology in the Resources Sector (IC250100003)

Led by Liam Brady. Claire Smith CI

This Centre aims to transform cultural heritage management in the resources sector by advancing the integration of archaeological expertise with mining activities. The Centre will use cutting-edge technologies and mining-specific frameworks to enhance archaeological outcomes in collaboration with Australia's largest resources companies, Traditional Owners, and cultural heritage consulting firms. Two-way knowledge exchange workshops will facilitate knowledge exchange between First Nations people and scientists. Expected outcomes include a new generation of archaeologists and mining leaders skilled in balancing mining impacts, cultural heritage and social responsibility. This project will help facilitate Australia's critical minerals strategy, safeguard Indigenous cultural heritage, and advance sustainable, culturally-informed resource management.

Indigenist Archaeology: New Ways of Knowing the Past and Present (IN220100079)

Led by Kellie Pollard. With Liam Brady, Nicolas Bullock, Craig Taylor

This project aims to explore how Indigenous Australian worldviews can transform archaeological practice and understandings of the past. Archaeological research practice has typically relied on Western science, theories and interpretive frameworks. As an alternative approach, we will develop a new epistemological conceptualisation for how archaeology can be practiced. Based on surveys and interviews with six Aboriginal communities in the Northern Territory and South Australia, and using Indigenous theories and concepts, the project will identify and explore how Aboriginal ways of knowing (epistemology), being (ontology) and doing (axiology) can be integrated into a new model for archaeological research that we call "Indigenist Archaeology".

Warraty: Cultural Innovation in the Indigenous Settlement of Australia (DP220101522)

Led by Claire Smith. With Emeritus Professor Mike Smith (former Lead Investigator, now deceased), Giles Hamm, Cliff Coulthard, Terry Coulthard, Mike Morley

This project aims to determine the role of cultural innovation in the Indigenous settlement of Australia's arid zone 50,000 years ago. Using innovative methods, it will produce new data on key technologies, symbolic behaviours and human interactions with animals and environment to identify the cultural innovations needed to overcome the challenges of Australia's deserts. Expected outcomes include new understandings of the settlement of the arid zone to inform global debates relating to the dispersal, settlement and lifestyles of early humans in marginal environments. Expected benefits include new information for cultural tourism and education and to support South Australia's World Heritage nomination for the Flinders Ranges.

'Slow' digitisation, community heritage and the objects of Martindale Hall (SR200200900)

Led by Jane Haggis, thence Penelope Edmunds. With Tully Barnett, Heather Burke, Margaret Allen, Ania Kotarba

This project aims to investigate how community history, heritage, and cultural collections can be better preserved and made accessible through slow digitisation techniques. The project will generate new interdisciplinary knowledge about Martindale Hall, SA, the historically significant objects it contains, and digitisation. Expected outcomes include a new method that embeds digitisation in historical and cultural knowledge, and assists organisations to make sustainable decisions about when and how to digitise. Benefits include improved public access to significant cultural heritage assets, return on investment for local history organisations, and protection of cultural heritage places and objects by the communities that care for them.

Ochre Archaeomicrobiology: a new tool for understanding Aboriginal exchange (DP190102219)

Led by Rachel Popelka-Filcoff. With Clare Lenahan, Amy Roberts, Robert Edwards, Shannan Trobe

This project aims to identify the origins and movements of Australian archaeological ochre through the development of a novel tool combining genomic and chemical analysis. This novel archaeomicrobiological technique could help answer significant questions about past human behaviour, in terms of trade, cultural interactions, territoriality and colonisation. It could also be used to reconnect Indigenous communities with cultural artefacts. The knowledge generated could form the basis of a new, globally applicable method for establishing the provenance of displaced artefacts.

Indigenous cultural heritage as a facilitator for the Sustainable Development Goals (SPARC 493)

With Alok Kanungo and Nishaant Choksi, Indian Institute of Technology, Gandhinagar

This project aims to develop a new culturally-informed model for using cultural heritage to facilitate the Sustainable Development Goals. The United Nations' Transforming Our World: The 2030 Agenda for Sustainable Development is one of the most ambitious and important global agreements in recent history. The traditional focus was on the environment, particularly environmental degradation. Cultural heritage has only recently been incorporated into this agenda. There is an urgent need for research to redress its prior omission.

Heritage Fallout: The impacts of nuclear colonialism in the Marshall Islands and South Australia (funding sought from the Opening New Horizons Program the Research Foundation - Flanders)

Led by Suzie Thomas and Hélène Verreyke, University of Antwerp, Belgium. With Alice Gorman, Setoki Qalabau.

This research aims to identify how cultural heritage can provide new insights into the impact on Indigenous populations of nuclear weapons testing at Bikini Atoll in the Marshall Islands, between 1946 and 1958, and at Maralinga and Emu Field in South Australia, between 1956 and 1963. It will analyse 1) the processes by which nuclear testing sites become transformed into official heritage, including their roles in national and World Heritage nominations; 2) the long-lasting impact of nuclear weapons testing on those communities whose lives have been most affected by this testing sites; and 3) How these impacts are expressed through tourism, community and survivor heritage practices and consumption. The research will contribute new knowledge to global discussions concerning the effects of human-induced climate change and environmental colonialism, including the banning of Indigenous fire management practices in Australia and the USA, the impact of rising sea levels, especially on Pacific populations, and land degradation, desertification and deforestation across the world.

Grave Concerns: the social, cultural and economic power of unmarked graves on Aboriginal lands

Commissioned by Local Authority Committee, Barunga, and Central Land Council, Alice Springs

In 2026 the majority of graves of Aboriginal people in remote areas of the Northern Territory and Western Australia are not recorded in any register. This project was initiated by the Local Authority at Barunga. Additional research has been commissioned by the Central Land Council, Alice Springs, on behalf of four Aboriginal communities in remote areas of the Great Sandy Desert and the Tanamai Desert. It has five aims. First, to properly record unmarked graves in Aboriginal communities in remote areas. Second, to develop a burial register for cemeteries in these communities. Third to develop a training to make Aboriginal management of these Aboriginal cemeteries a reality. Fourth, to determine the viability of establishing a consultancy business in which Aboriginal people from Barunga and related communities record unmarked graves in remote Aboriginal communities throughout the Northern Territory, and elsewhere. Fifth, to analyse the graves in terms of changes and continuities in social, cultural, economic and religious power during the contact period.
